Performing at Blues at Bridgetown's Street Party is a great way for you (or your group) to showcase your talents and get experience performing to large audiences. It's an ideal platform for students of theatre and performing arts, repertory theatre groups, community groups as well as professional performers. With over 15,000 people attending the Street Party throughout the day you'll get lots of exposure – a great way to promote yourself.

Depending on your type of performance, you may be required to have your own public liability insurance. In some cases you may be covered by our insurance. It is not possible to ascertain if you are required to have your own insurance until we receive and process your application. We will discuss this aspect with any applicants shortlisted for approval.

## APPLICATION CHECKLIST

Your application will only be considered if it is accompanied by all required documentation and fully completed. Use this checklist to ensure you are submitting your application correctly.

# STREET ENTERTAINERS – TERMS AND CONDITIONS

---

## GENERAL

1. Entertainers are to treat other entertainers, customers and event personnel with respect. Inappropriate behaviour will not be tolerated.
2. Entertainers must follow all directions/instructions issued by event personnel.
3. Blues at Bridgetown Inc. reserves the right to decline any application. Decisions are final and no correspondence will be entered into.
4. Entertainers are responsible for any damage they cause to other property.
5. Entertainers may not sell any product or item that has not been approved prior to the event.
6. The following goods are not permitted: • Weapons or imitation weapons (including toys) • 'Fun string' and 'silly string' type products • Shaving cream • Any goods prohibited by law.
7. Hazardous or flammable goods are not permitted unless they have been approved as part of your performance, approved in writing by Blues at Bridgetown Inc. prior to the event, and handled under the strict conditions specified by Blues at Bridgetown Inc.
8. Failure to comply with any Term or Condition will adversely affect any application for a future event. It may also result in you being removed from the event site.
9. No dogs or other animals are permitted.

## PERFORMANCE HOURS & LOCATION

10. Blues at Bridgetown Inc. will agree and confirm with Entertainers their performance time(s) and location(s). Entertainers are not permitted to perform at any location at any other time.
11. Blues at Bridgetown Inc. determines performance time(s) and location(s) in the best interests of the Festival.
12. Blues at Bridgetown Inc. reserves the right to reschedule performance times and/or change locations at anytime as/if required for any operational reason(s).
13. Performing locations will not be the same as in previous years due to changes to event layouts.
14. The majority of performance locations are not shaded. Entertainers should ensure they have adequate sun as well as rain protection for inclement weather.

## PERFORMERS UNDER 18 YEARS OF AGE

15. Performers under the age of 18 years at the time of the event must be under the care of a parent or guardian.

## ENTERTAINER'S EQUIPMENT/PROPS

16. Entertainers must bring all their own equipment/props.
17. Any amplification equipment must be self powered – Blues at Bridgetown Inc. does not supply power to street locations for Entertainers.
18. Equipment/props must be placed with care as to not create trip hazards.
19. Equipment/props must be carried or trolleyed back to vehicles. Care must be taken as the area is crowded with pedestrians.

## ROAD CLOSURE, PARKING & ACCESS

20. Road closure is planned to be in effect from Saturday 7:00am to Sunday 4:00am.
21. During road closure times, no vehicles are permitted on the road.
22. Outside road closure times, vehicles are permitted and must abide by all normal traffic and parking rules/regulations as the road in normal operation.
23. There is no parking provided for Entertainers. There is ample parking the surrounding areas during the event.
